## ORDER

This order may be read with reference to the previous order dated 1.6.2021.

2. The appellant has sought the following information:-

- 1) ਸਾਲ 2017 ਵਿਚ ਕੀਤੇ ਗਏ ਇੰਤਕਾਲ ਨੰਬਰ 40067,40943,40944,40945,40946,41085 ਦੀਆਂ ਰਜਿਸਟਰੀਆਂ, ਮੁਖਤਿਆਰ ਨਾਮਾਂ, ਤਬਦੀਲ ਮਲਕੀਤ ਦੀਆਂ ਕਾਪੀਆਂ ਦਿਤੀਆਂ ਜਾਣ ਜੀ। ਜਮਾਬੰਦੀ ਫਰਦ, ਗਰਦੇਰੀਆਂ ਦੀਆਂ ਕਾਪੀਆਂ ਦਿਤੀਆਂ ਜਾਣ ਜੀ।
- 2) ਇਨ੍ਹਾਂ ਇੰਤਕਾਲਾਂ ਤੋਂ ਬਾਅਦ ਦੇ ਹੁਣ ਤੱਕ ਇਸੇ ਜਗ੍ਹਾ ਦੀ ਕੋਈ ਤਬਦੀਲ ਮਲਕੀਤ ਜਾਂ ਰਜਿਸਟਰੀਆਂ, ਜਾਂ ਕਿਸੇ ਵੀ ਤਰ੍ਹਾਂ ਨਾਲ ਹੋਏ ਇੰਤਕਾਲ ਹਨ ਉਨ੍ਹਾਂ ਦਸਤਾਵੇਜ਼ਾਂ ਦੀਆਂ ਕਾਪੀਆਂ ਦਿਤੀਆਂ ਜਾਣ ਜੀ।

3. The appellant states that he has received the complete information except related to intkal No. 41925 and requested to direct the respondent-Public Information Officer to supply the same. However, the respondent-Public Information Officer requested that the same is not part and parcel of the sought information and requested to direct the appellant to file the application fresh. He also assured that in case the appellant file the application afresh the same will be dealt with expeditiously.

4. Accordingly, the submissions of the respondent-Public Information Officer is accepted and the appellant is advised to file the application afresh in case she wants to get the information related to Intkal No. 41925 and the respondent-Public Information Officer will ensure that the same be dealt with expeditiously as has been assured by him.

5. With these directions, the Commission observes that no further action is required to be taken in this case. Hence, the case is disposed of and closed.
