1. To be read in the continuity of previous order dated 10.05.2021.

Relevant facts emerging during hearing:

2. Respondent, Sh. Manjinder Singh stated that sought information has been supplied to the appellant dated 04.05.2021. A copy of the same is received in the commission dated 11.05.2021 vide diary 10294.

{Meantime the information was emailed to the appellant at the bombaystudio@gmail.com }

- 3. Appellant, Sh. Ankit Sehgal contended that information so supplied by the respondent authority is not in appropriate form, as it is not clear that it pertains to which Zone. He further added that the respondent authority has also not returned the balance amount, which he had paid to supply the information.
- 4. On this, the PIO replied that the information sought was not maintained by the authority in the format as desired by the appellant and segregation of the information sought would result in disproportionate diversion of their resources. He further assured the appellant to return the balance amount.

Appeal Case No.841, 842,843 & 844 of 2021 (Cisco Webex Proceedings)

Observation:-

5. The Commission observes that the PIO, under the RTI Act, is required to furnish information/documents as available on record and is not supposed to segregate or collate information in the manner in which it was sought by the appellant.

The Hon'ble Supreme Court in decision dated 09/08/2011 in the matter of CBSE & Anr. Vs. Aditya Bandopadhyay & Ors. (C.A. No. 6454 of 2011) held:

"35...... But where the information sought is not a part of the record of a public authority, and where such information is not required to be maintained under any law or the rules or regulations of the public authority, the Act does not cast an obligation upon the public authority, to collect or collate such non- available information and then furnish it to an applicant.....

67....... The nation does not want a scenario where 75% of the staff of public authorities spends 75% of their time in collecting and furnishing information to applicants instead of discharging their regular duties. The threat of penalties under the RTI Act and the pressure of the authorities under the RTI Act should not lead to employees of a public authorities prioritizing information furnishing, at the cost of their normal and regular duties."

The matter has been further clarified by the Division Bench of Hon'ble Delhi High Court in its decision dated 07/01/2016 [LPA 24/2015 & CM No. 965/2015 The Registrar of Supreme Court of India vs Commodore Lokesh K Batra & Ors.] holding as under:

"15. On a combined reading of Section 4(1)(a) and Section 2(i), it appears to us that the requirement is only to maintain the records in a manner which facilitates the right to information under the Act. As already noticed above, "right to information" under Section 2(j) means only the right to information which is held by any public authority. We do not find any other provision under the Act under which a direction can be issued to the public authority to collate the information in the manner in which it is sought by the applicant."

Decision:-

6. In view of the above observations, the PIO is directed to provide an additional reply to the appellant on all of the points raised in the RTI applications as discussed above. Moreover, the PIO is directed to furnish an affidavit providing therein the factual situation and affirming the position that the information sought by the appellant has been supplied to their best extent. In case the partial information is not available in the office record then an undertaking/affidavit may be filled in this regard also to the appellant with a copy to the Commission.

The PIO is also directed to refund the balance amount which was paid by the appellant as an addition fee for getting the information, with detailed layout.
