Then he filed Second Appeal before the Punjab State Information Commission on 08.03.2021. The case was registered and allocated to the Bench. The notice of hearing was issued to both the parties to be heard through CISCO Webex Meetings Software.

Both the parties are present today.

The SPIO stated that the appellant sought information through 1 to 5 points of his RTI application and vide letter no.13121 dated 12.10.2020 the appellant was informed that the record regarding point nos.4 and 5 is not available. He further stated that letter no.13608 dated 27.10.2020 was written to the appellant and he was asked to deposit the amount of Rs.59800/as assessed fee for the information related to point nos.1, 2 and 3 of the RTI application as he has sought information regarding record of all the villages of Lahore district of Pakistan, but in response the appellant written that the assessed fee is too much, so he requested that only the names of 1243 villages of Lahore District be provided to him.

I have gone through the RTI application and also discussed about the sought for information with both the parties. After discussion the appellant stated that he will be satisfied if the list of 364 villages of the Lahore Tehsil be provided to him.

So, the SPIO is directed that the attested copies of the list of 364 villages of the Lahore Tehsil be provided to the appellant after receiving the assessed fee @ Rs.2/- per page and compliance be sent to the Commission accordingly.
