Ravinder Pal Chadda is not present for today's hearing but an email dated 22.10.2018 has been received by the Bench of Undersigned stating that requisite information has not been received from the respondent PIO. In that email he requested for an adjournment. This mail is taken on record.
3. Respondent, Sh. Jeet Pal Joshi states that requisite information has been supplied to the appellant through speed post. He submits a letter no. 2579 dated 22.10.2018 signed by PIO, MTP Dept., Nagar Nigam, Jalandhar along with supporting documents, which are taken on record.
4. After hearing the respondent and examining the case file, respondent PIO is directed to supply the requisite information in connection with point no. 1 and 4 to the appellant before the next date of hearing.

It is observed that appellant; Sh. Ravinder Pal Chadda mentioned appeal case no. 2617 of 2018 in the letter received in email instead of appeal case no. 2627 of 2018 is pending before the Bench of Undersigned. Another opportunity is given to the appellant, Sh. Ravinder Pal Chadda to go through the requisite information and point out the deficiency, if

any, in written to the respondent PIO along with a copy to the Commission, once he had received the requisite information from the respondent PIO. He is also advised to represent this case in person or through any of his representative(s) on the next date of hearing to clear the facts of this case positively, failing to which case will be decided on merit basis.

5. The matter is adjourned for further hearing on **21.11.2018 at 11:30 A.M.**
