The appellant himself shows a copy of letter dated 07.05.2018 through which the information was provided to him that Smt. Uma Rani, D/o Shri Girdhari Lal was not an employee of the school for the last three years. I have asked the appellant that have you any relation with Smt. Uma Rani and he replied that she is his wife and they have a matrimonial dispute. During the hearing the counsel of the Respondent stated that the respondent school is neither managed and controlled by the Government nor it is getting any financial grant-in-aid from the Government. So, the Respondent school is not a public authority and is not bound to provide the information as the RTI Act does not apply upon it.

I have asked the appellant that whether you have any proof that the respondent school is a public authority, then he stated that he does not have any proof regarding this.

So, I am of the view that though the information had already been provided to the appellant by the school authorities even then the school does not come within the cover of the RTI Act. The Respondent school is not a public school and is not bound to provide the information to the appellant.

As the school authorities has provided the information to the appellant, so the present appeal case is **dispose of and closed**.

brings the deficiencies to his notice, then he should resolve the matter and provide the remaining information to the appellant within 7 days from the receipt of the deficiencies.
