ORDER

This order may be read with reference to the previous order dated 26.09.2018 vide which the appellant was given inspection rights.

2. Today the appellant states that the Commission has given him inspection rights on the last date of hearing, but Respondents misbehaved with him when he went to his office to collect the information, respondents.

3. This shows that the respondents have no regard for the orders issued by the Commission. This is indeed a serious matter. The perusal of the file shows that the appellant filed RTI on 06.04.2018, but the respondents have not given any information after lapse of more than six months. This has resulted in much avoidable inconvenience and hardship to the Appellant. He is, therefore, entitled to be compensated under Section 19(8)(b) of RTI Act 2005 for the loss and detriment suffered by him. In the circumstances, I am of the view that ends of justice would be met if a sum of **Rs.5000/- (Rupees Five Thousand Only)** is awarded to the Appellant as compensation. I order accordingly.

4. This amount shall be payable by the Respondent from the State exchequer within fifteen days from the receipt of this order under intimation to the Commission.

5. Looking at the lackadaisical and highly irresponsible attitude of the respondents, **Sh. Rabinder Singh Sethi, SMO-cum-PIO** is directed to show cause under Section 20(1) of the RTI Act, before the penalty is imposed as to:-

- (i) Why supply of information as per RTI request sent to him has been delayed.
- (ii) Why penalty be not imposed upon him for not supplying the information within time as prescribed under RTI Act 2005.

6. Respondent-PIO is directed to file an affidavit in this regard before the next date of hearing. Respondent-PIO is also directed to supply complete information to the appellant before the next date of hearing.

7. He may also make use of the next date of hearing for his personal hearing as well under the principles of natural justice.

8. Adjourned to **20.11.2018 (at 11.30 AM)** for further proceedings. Copies of the order be sent to the parties **through registered post**.

ਦਾਇਰੇ ਵਿਚ ਨਹੀਂ ਆਉਂਦੀਆ, ਮਾਨਯੋਗ ਸੁਪਰੀਮ ਕੋਰਟ ਫੈਸਲੇ ਵਿਚ ਸਪੱਸ਼ਟ ਕੀਤਾ ਗਿਆ ਹੈ ਕਿ ਸਹਿਕਾਰੀ ਸਭਾਵਾਂ ਉਪਰ ਸਰਕਾਰ ਦਾ ਸਿੱਧਾ ਜਾਂ ਅਸਿੱਧਾ ਨਿਯੰਤਰਨ ਨਹੀਂ ਹੈ।"
