Manjit Singh through registered post. It, alongwith a copy of postal receipt, is taken on record.

The appellant, Sh. Manjit Singh, who appeared in person in today's hearing, submits a written-submission dated 23.10.2019, stating that he has received the information except copy of Form 24, which was demanded through his RTI request.



The respondent PIO concerned is directed to provide the remaining information regarding Form 24 to the appellant positively by registered post before the next date of hearing. He is also directed to submit/send the postal receipt, through which information would be sent to the Appellant on the next date of hearing.

After examining the documents placed on record, it emerges that the respondent PIO concerned has not complied to the orders dated 24.04.2019 passed by the Commission, through which a penalty of Rs. 5000/- was imposed upon PIO of office of Sub Divisional Magistrate, Maur in the above mentioned five cases 'collectively' and orders dated 24.06.2019 passed by the Commission, through which compensation of Rs. 5000/- was awarded to the appellant in the above mentioned five cases 'collectively'.

Last opportunity is given to the respondent PIO concerned to comply with the orders dated 24.06.2019 passed by the Commission by paying compensation of Rs. 5000/-collectively to the appellant before next date of hearing. The compensation shall be paid by public authority concerned by way of <u>crossed cheque/Demand Draft in the name of Manjit Singh.</u> The crossed cheque/Demand Draft shall be made from the bank account of public authority concerned and not from the individual official.

After examining the documents placed on record, it also emerges that despite giving several opportunities to the concerned Public Information Officer, he/she has not complied to the orders dated 24.04.2019 passed by the Commission, through which a penalty of Rs. 5000/- was imposed upon PIO of office of Sub Divisional Magistrate, Maur, the Commission took a very serious view of this casual approach of the respondent PIO, accordingly, penalty amount is enhanced from Rs. 5000/- to 25000/-

The respondent PIO concerned is directed to comply with the abovesiad orders passed by the Commission in above mentioned five cases by depositing the penalty amount of Rs. 25,000/- collectively by the next date of hearing in the Treasury of Punjab Government under the head :
