1. The RTI application is dated **13.8.2019** vide which the appellant has sought information **regarding the death-cum-retirement benefits of her husband Gurmit Singh**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **4.1.2020** and Second Appeal was filed in the Commission on **18.9.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard on **30.9.2021**.

2. The respondent PIO is absent without intimation. In case there are still some deficiencies, the appellant is advised to intimate the respondent PIO listing said deficiencies. A copy of the same is to be sent to the Commission.

1. The RTI application is dated **26.8.2020** vide which the appellant has sought information **regarding Muraba No. 71 and 81**, as enumerated in his RTI applications. First Appeal was filed with the First Appellate Authority (FAA) on **13.10.2020** and Second Appeal was filed in the Commission on **8.6.2021** under Section 19 of the Right to Information Act, 2005.
