1. The RTI application is dated **10.4.19** vide which, the appellant has sought information **regarding sweepers on contract in the Municipal Council from 2018-2019**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **15.5.19** and Second Appeal was filed in the Commission on **4.7.19** under Section 19 of the Right to Information Act, 2005. The case was last heard on **30.9.2021**.
2. Both parties are present. As per the respondent PIO, represented by Ramesh Kumar, Inspector from Nagar Council, Fatehgarh Churian, the requested record was given to the appellant vide Letter No. 191 Dated 10.2.2021. The appellant however, continues to express dissatisfaction with the record supplied.
3. The Commission notes that the respondent PIO has already been penalized by imposing a penalty of Rs. 5000/- vide this Commission's Order of 9.1.2020. A compensation of Rs. 6000/- was also awarded to the appellant Sh. Sukhchain Singh. Both, the penalty and compensation have been paid.
4. Taking note of the appellant's dissatisfaction, this Commission is of the view that this RTI application has been finally addressed. This Appeal Case is herewith **CLOSED**.
