#### ORDER

- 3. The respondent 3<sup>rd</sup> party Sh. Gursher Singh has submitted in writing that the sought information pertaining to him is personal information and should not be disclosed to the appellant. His submissions vide letter dated 15.6.2022 is taken on record.
- The representative of the respondents states that appellant has sought 3<sup>rd</sup> party information and hence he was denied information pertaining to point no. 2 and 3 under section 8(1)(J) of RTI Act,2005 vide letter no. 15554 dated 3.12.2021 which is available in the case file.
