1. The RTI application is dated **12.4.19** vide which the appellant has sought information **regarding agricultural subsidies and funds received etc.** as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on **18.6.19**, and second appeal was filed in the Commission on **6.8.19**, under Section 19 of the Right to Information Act, 2005. The case was last heard on **30.1.2020**.

2. Both parties are absent without intimation. At the last hearing on 30.1.2020, the respondent PIO had submitted information pertaining to point No. 2 of the RTI application which had been listed as deficient by the appellant.
