The First Appellate Authority vide their letter dated 3.10.2019 replied to the appellant stating that *"the reply has already been sent to you vide this office letter No. P&G19/2019/EC/2796 dated 3.9.2019 that your candidate was provisional in the Examination Process of Punjab State Civil Services Combined Competitive Exam 2018 and cancelled later due to the dismissal of court cases filed by* 

you. Therefore, as you are no longer a candidate in the examination of Punjab State Civil Service Combined Competitive Exam 2018, the answer sheets/information cannot be provided to you".

3. Aggrieved from the order passed by the First Appellate Authority, the appellant filed Second Appeal in the Commission on 04.11.2019 and Commission issued notice on 19.11.2019 for appearance on 04.12.2019. The respondents sent a letter dated 19.11.2019, the specific contents are reproduced below:-

"With reference to this office letter dated 03.09.2019 you were informed that your candidates was provision in the exam process of PSCSCC Exam 2018 and cancelled later due to the dismissal of court cases filed by you, therefore, as you are not longer a candidate in the examination of the examination of PSCSCC Exam 2018, the photocopies of answers not provided to you.

It is to inform you that Public Information Officer has been directed to refund the fee of your RTI documents which were not provided to you for the reasons submitted above. Alongwith this letter plea find herewith IPOs amounting to Rs.500/-which were submitted by you alongwith your RTI application. It is also informed that as you had not submitted any IPO amounting to RS.10/- as RTI fee, hence IPO having minimum amount (I.e. Rs.100/- IPO No.354900) has deposited to the Accounts Officer of the Public Authority as fee for seeking information".

4. In reply to the notice dated 19.11.2019 issued by the Commission, the respondent-PIO has stated that *"this has with reference to the notice in appeal case NO.4113 of 2019 dated 19.11.2019 (received in this office on 26.11.2019) in connection with RTI application dated 31.07.2019 (received on 5.8.2019), 24.09.2019 (received on 24.09.2019) of Shri Ankur Goyal. Shri Ankur Goyal's candidature was admitted provisional in the Examination Process of Punjab State Civil Services Combined* 

Competitive Exam 2018 as per the interim order of Hon'ble Punjab and Haryana High Court. The Hon'ble High Court dismissed the writ petition vide order dated 27.05.2019 hence the candidature of Shri Ankur Goyal has been rejected. Fee received from Shri Ankur Goyal has also refunded by the PPSC vide this office letter dated 19.11.2019. Hence, grievance received this office from Shri Ankur Goyal had already been replied vide this office letter dated 03.09.2019 (copy enclosed) and fee refunded vide this office letter dated 19.11.2019. You are therefore requested to kindly dismiss the appeal case No.4113 of 2019."

5. The RTI Act, so declares its preamble, was enacted to promote transparency and accountability and to establish the practical regime of right to information. Competitive examination conducted by various Constitutional/statutory/ government departments, for recruitment to public services, are not exempted from its purview, The entire gambit of selection process to government services, including the evaluated answer sheets of examinees, fall well within the pale of public gaze and therefore could be under the RTI Act. The Apex Court had held in the State of UP vs. Raj Narain, AIR 1975 SC 865, that a citizen has a right to know every public act and for the matter everything done in a public way by public functionaries.

6. After hearing the respondents and going through the record available on the case file, it is revealed that the appellant is asking copies of his own answer sheets, which is available on the record of the respondents. Information as defined in Section 2(f) means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports papers, samples, models data material held in any electronic form and information relating any private body which can be accessed by a public authority under any other law for the time being in force. The Preamble states that democracy requires an informed citizenry and transparency of information which are vital to its functioning and also to contain corruption and to hold Governments and their instrumentalities accountable to the governed. Decision taken by the respondents is not according to the provisions of Right to Information Act, 2005. Denial of such information will defeat the very purpose of the Act, ibid which the preamble states was enacted by the Parliament to promote transparency and accountability in the working of every public authority. The RTI Act

clearly provides that any information which is in the control or held by Public Authority has to be provided unless it falls in one of the exempted categories as provided in Section 8 and 9 of the Act. The applicant is asking for his own answer sheets, which cannot be denied to him/her as there is no provision in the RTI Act or the rules. Thus, the Applicant would be well within his/her rights to claim the copies of the answer sheets pertaining to him. Further as far as the question of precedence is concerned, the Commission is of the considered view that future probable inconvenience to PPSC cannot over ride the statutory provisions of the RTI Act and hence on this ground as well the stand of the PPSC cannot be sustained, even if candidature of the appellant in this case has been cancelled by Hon'ble Punjab and Haryana High Court. In view of larger public interest if the answer-sheets duly evaluated is shared with any ineligible candidate, as in this case, will help him in preparing for next examination or it will help the candidate in knowing his performance which would help him in other examinations also. As such the Commission holds it in larger public interest to share this information and rejects the position taken by the PPSC. The respondents are directed to supply the information before the next date of hearing.
