ORDER:

(Heard in person/Through Cisco Webex)

1. This order may be read with reference to the order dated 18.10.2021 passed by this Bench on the previous hearing.
2. The appellant has come present to attend the hearing in person before the Bench. He reiterates his statement as made during the previous hearing regarding the variation in the information supplied by Tehsildar, Dhar Kalan and the office of Divisional Forest Officer, Pathankot.
3. Shri Sanjeev Sharma, Superintendent O/o Divisional Forest Officer, Pathankot comes present to attend the hearing on behalf of the PIO through cisco webex and states that the information as available in the official records has been supplied to the appellant and an affidavit, as per directions of the Hon'ble Commission, has been sent to the appellant vide letter dated 10.01.2022.
4. Shri Sarabjit Singh, Office Kanungo O/o Tehsildar Dhar Kalan comes present to attend the hearing through cisco webex on behalf of the PIO. He states that the information sought by the appellant has been supplied to the appellant and as per directions of Hon'ble Commission, an affidavit dated 19.01.2022 has also been sent to the appellant on 20.01.2022.

4. The appellant states that he has not received affidavit from the Tehsildar, Dhar Kalan and then, he is shown a copy of the affidavit dated 19.01.2022. On the asking of the Bench, the appellant states that the information supplied is incomplete and he is not satisfied with the information as there is variation in information supplied by the Tehsildar and the Forest Department and he states that he had sought information regarding villages in 27550 acres of land whereas he has been supplied information only in respect of 27202 acres. The appellant also contends the contents of affidavits and states that in case of RTI application of another person, the information has been supplied in respect of 27550 acres but he is being denied correct and complete information.

5. On the asking of the Bench, the APIO, O/o Tehsildar, Dhar Kalan states that the appellant has been supplied information in respect of the area of 27202 acres out of 27550 acres as the mutation of 27202 acres only has been done and the mutation in respect of the remaining area of land is still pending and that the information in respect of land of which mutation has been done, can only be supplied by the office of Tehsildar. On the asking of the Bench, Shri Sanjeev Sharma, Superintendent o/o D.F.O. Pathankot states that on 18.11.2021, the appellant was called to their office and the record available in the Divisional Office was shown to him which has already been supplied to him on 13.05.2021 by registered post. The appellant was also apprised that no record, as sought by him, in addition to the one shown to him, is available in their office. He is directed to send a copy of the same to the Commission by e.mail today itself.

6. The Bench observes that it is fifth hearing in the instant appeal case. The appellant as well as the representatives of PIOs have been heard at length. After hearing their versions and after going through the documents available in the case file as also the contents of the affidavits produced by the PIOs concerned, the Bench does not feel any need of further intervention in the matter. **The instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
