- 1. This order may be read with reference to the order dated 22.01.2020 passed by the Bench on the last date of hearing.
- 2. The Appellant comes present and states that he has received partial information with regard to his RTI application. The Bench felt that it is only just that the appellant be financially


compensated at least for the expenditure incurred by him in making many trips in seeking information thus far. As such, I award a compensation of Rs.3000/- (Rupees three thousand only) to the appellant. He is also directed to send a photocopy of the cheque or draft to the Commission.



5. After discussions held with the APIO in the matter, it has been observed that the appellant is in the habit of seeking information time and again on the same subject in various forms which, apparently, serves no public cause. The appellant by doing so, has been wasting the precious time of the public authority. The filing of RTI applications repeatedly by the appellant amounts to keeping the officials of a public authority busy in supplying the information to the information seekers. RTI Forum cannot be used as an instrument to harass the public authorities. The Hon'ble Supreme Court of India in matter of CBSE vs. Aditya Bandopahdyaya, (2011) 8 SCC 497, explained as under:

"Indiscriminate and impractical demands or directions under the RTI Act for disclosure of all and sundry information (unrelated to transparency and accountability in the functioning of public authorities—and eradication of corruption) would be counterproductive as it will adversely affect the efficiency of the administration and result in the executive getting bogged down with the non-productive work of collecting and furnishing information. The Act should not be allowed to be misused or abused, to become a tool to obstruct the national development and integration, or to destroy the peace, tranquility and harmony among honest officials striving to do their duty. The nation does not want a scenario where 75% of the staff of public authorities spends 75% of their time in collecting and furnishing information to applicants instead of discharging their regular duties. The threat of penalties under the RTI Act and the pressure of the authorities under the RTI Act should not lead to employees of public authorities prioritizing "information furnishing", at the cost of their normal and regular duties.

- 5. The Bench finds substance in the submissions made by the APIO. Seeking repetitive information in stereotyped applications certainly amounts to misuse, rather abuse of the RTI Act. The instant case squarely comes in the domain with regard to which the Hon'ble Supreme Court of India was constrained to make above mentioned observations.
- 6. In view of the above, **the appeal is disposed off and closed.** Copies of the orders be sent to the parties.
