**ORDER**

2. **Information Sought :**

The appellant has sought the information and documents pertaining to his complaint filed dated 24.06.2020 for taking NOC.

3. **Facts emerging during the hearing:**

Appellant Sh. Surinder Kumar contended that partial information has been supplied to him till date though he has deposited the fee for requesting the information.

On this Respondent, Sh. Harjinder Singh made his written submission in the commission and the relevant portion of which is reproduced below:-
