inspection the photo copies of the information related with the RTI application so identified by the representative of the appellant, is handed over to him pertaining to point no. 3,33,35 with which the appellants showed their satisfaction. The representative of the appellant further submits that the present Panchayat Secretary, Shri Gurmail Singh has supplied the incomplete record pertaining to point no. 1,24,34,36,37,38 and 39 as he has sought the up to date record. Shri Lal Chand representative of the appellant has submitted a letter to the Commission and requests to provide the complete information pertaining to point 1 and information regarding point no. 31 and 32. The representative of the appellant also submits copies of resolution dated 21.7.2020 and 4.8.2020 of proceeding book and requested to direct the respondents to supply the certified copy of the same, which were made available to them by Sarpanch Amrik Kaur as the same proceeding book was not shown/made available by the concerned Panchayat Secretary. The letter submitted by the representative of the appellant is taken on the record.

3. The respondent PIO further states that he has joined this office in the month of December 2020 and his predecessor Shri Harpal Singh, Panchayat Secretary has handed over incomplete record pertaining to point no. 1, 24,34,36,37,38,and 39, which he has already supplied to the appellant. He further states that his predecessor has not handed over the record pertaining to point no. 2,4 to 23 and 25 to 30. Furthermore, he states that he has brought this fact to the notice of his higher authorities. He also submits his charge report (charge taken over and handed over report), which is taken on record. He also states that information pertaining to Point no. 40 and 41 relates to Manrega and the same can be downloaded from the website www.narega.gov.in. Regarding point no 42 and 43 the respondent-Public Information Officer states that the same relates to the District Social Security Officer and the appellant may be advised to file the application afresh with which the appellant agreed to. The respondent Public Information Officer assured that he will provide the information /copies of documents pertaining to Point No. 1,31, 32 and the copies of the proceeding book of 21.7.2020 and dated 4.8.2020 before the next date of hearing.

- 4. During the hearing dated 30.10.2020, Shri Harpal Singh M 7986799254 previous Panchayat Secretary had admitted before the Commission that the original record is in the custody of Divisional Deputy Director, Rural Development and Panchayat, Department ,Punjab, Patiala as the inquiry is being conducted by him against Ex-Sarpanch. Thereafter, Divisional Deputy Director, Rural Development and Panchayat, Department, Punjab, Patiala was impleaded as a necessary party and was directed to file his response/provide the information to the appellant. He is absent without intimation during the last two hearings and also he has not filed any response in this regard. Viewing the attitude of the respondent-Public Information Officer in dealing with the RTI application seriously, Sh. Gagandeep Singh Virk, Public Information Officer-cum-Divisional Deputy Director, Rural Development and Panchayat, Department ,Punjab, Patiala is, thus, issued a show cause notice to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing wilful delay/denial of the information to the RTI application.
- 5. In addition to the written reply, the PIO is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take a note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the next date, it will be presumed that he has nothing to say and the Commission will proceed ex-parte.
- 6. The respondent Public Information Officer o/o Divisional Deputy Director, Rural Development and Panchayat, Department, Punjab, Patiala is directed to file his response/provide the information as mentioned above and remain present on the next date of hearing. A copy of the charge report of Shri Gurmel Singh is **sent** along with this order.

A copy of the letter submitted by the representative of the appellant is **sent** along with this order to the respondent Public Information Officer Shri Gurmel Singh, Panchayat Secretary with the directions to supply the remaining information before the next date of hearing as has been assured by him.
