ORDER

This order may be read with reference to the previous order dated 18.1.2021.

2. The complainant has sought the following information:-

2. ਇਹ ਵੀ ਦੱਸਿਆ ਜਾਵੇ ਕਿ ਇਸ ਅਰਸੇ ਦੌਰਾਨ ਡਾਇਰੈਕਟਰ ਕੋਰਟ ਵਿੱਚ ਕਿੰਨੀਆਂ ਨਵੀਆਂ ਪਟੀਸ਼ਨਾਂ ਸੁਣਵਾਈ ਲਈ ਦਾਇਰ ਹੋਈਆਂ ਹਨ।”

3. The representative of the respondents submitted the copy of reply bearing No. 520 dated 19.2.2021 along with the annexures which is taken on record. After hearing the contents of the said letter, the complainant shows his satisfaction. The complainant further requested for a hard copy of the same and states that he has no objection if the present complaint is disposed of.

2. The appellant has sought the following information:-

3. The respondent-Public Information Officer has sent a letter bearing memo No. 1/143183/2021 dated 11.2.2021, which is taken on record.

2. The appellant has sought the following information:-

3. The representative of the respondents states that complete information as available on record has already been supplied to the appellant. 4. The commission is of the view that as far as the information sought is concerned, the complainant has already received the same as available on record. Therefore, the Commission observes that no further action is required to be taken in this case. Hence, the case is disposed of and closed.
