ORDER:

The appellant through RTI application dated 17.06.2020 has sought information regarding status of action taken on the complaint filed to Minister of Local Bodies relating to irregularity and non transparency in allotment of tender No.2018-DLG-18232-1 of stray dog sterilization to Dr.Ankit Narang from the office of Local Bodies, Punjab Chandigarh. The appellant was not provided the information after which the appellant filed first appeal before the First Appellate Authority on 22.07.2020 which took no decision on the appeal.

The case has come up for hearing today through video conferencing at DAC Mohali. The appellant claims that the PIO has not provided the information.

The respondent is absent. The PIO is given one more opportunity to provide whatever action has been taken on the complaint of the appellant alongwith notings within 15 days with a copy to the Commission, otherwise the Commission will be constrained to take action under section 20 of the RTI Act against the PIO.

ORDER:

The appellant through RTI application dated 27.09.2020 has sought information regarding complete report submitted by the Board of Doctors to the Civil Surgeon relating to investigation on the complaint dated 23.06.2020 against Dr.Karanveer singh Saluja for cheating and committing fraud and other information as enumerated in the RTI application from the office of Civil Surgeon Ludhiana. The appellant was not provided the information after which the appellant filed first appeal before the First Appellate Authority on 20.11.2020 which took no decision on the appeal.

The case has come up for hearing today through video conferencing at DAC Ludhiana. The respondent present pleaded that the information has been sent to the appellant vide letter dated 22.02.2021. The appellant claims that she has not received the information.

The Commission has received a copy of the information from the PIO through email which has been taken on the file of the Commission. A copy of the information was handed over to the appellant. The appellant is not satisfied with the information and stated that the investigation report is incomplete and without supporting documents.

Having gone through the information and hearing both the parties, the PIO is directed to provide the complete investigation report along with all supporting documents/statements of all parties submitted by the Board of Doctors to the Civil Surgeon. The appellant is directed to collect the same from the office of PIO by hand on 01.03.2021 at 12.00 Noon as agreed.

With the above order, the case is **disposed off and closed**. However, the Commission makes it clear that if the complete information is not provided, the appellant is free to come to the Commission again.
