ORDER

1. The RTI application is dated 06.09.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 14.10.2021 and the second appeal was filed in the Commission on 01.12.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 24.02.2022 through cisco webex. As such, the case has been heard today. Shri Arvinder Singh, appellant comes present to attend the hearing through cisco webex. He states that he has not received information so far.

3. Shri Sukhjinder Singh, Panchayat Secretary, Gram Panchayat, Nanhera, Block Shambhu, District Patiala comes present to attend the hearing through cisco webex. He states that similar information was asked for by the appellant earlier which was supplied to him. On enquiring from him as to why the information has not been supplied so far. He states that he has received RTI application in the month of January, 2022 and he was deputed on election duty, as such, could not supply information to the appellant earlier. On the asking of the Bench, he assures that he will provide information to the appellant today itself.

4. The Bench directs Shri Sukhjinder Singh, the representative of PIO to hand over information to the appellant today itself.
