ORDER:

- 1. This order may be read with reference to the order dated 11.01.2021 passed by the Bench on the previous hearing.
- 2. The appeal case has been heard today through V.C. in D.C. Office, Ludhiana. Shri Gagandeep Singh Thareeke, appellant attends the hearing through V.C.

6. The Bench on perusal of the case file, observes that the reply to the show cause notice has been filed by the PIO vide letter dated 09.03.2020, as such, the show cause notice is dropped.

Post deliberations, the PIO is directed to supply the rectified information after removal of deficiencies to the appellant before the next hearing and bring along all the relevant records and produce the same before the Bench on the next hearing. The PIO is also directed to file an affidavit after giving rectified information on non judicial stamp paper within fifteen days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.3022/2020 has been supplied to the appellant. It be further stated that nothing has been concealed therein and statement made is true and correct. Original affidavit be sent to the appellant and photocopy of the same be sent to the Commission for record.

ORDER:

- 1. The RTI application is dated 21.10.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 24.11.2020 and the second appeal was filed in the Commission on 31.12.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. Notice of hearing was issued to the parties for 24.03.2021 through V.C. in D.C. Office, Ludhiana. The appellant has not come present for today's hearing. However, Ms. Deepti Saluja, Advocate attend the hearing on his behalf. ORDER:

- 1. The RTI application is dated 21.09.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 03.11.2020 and the second appeal was filed in the Commission on 31.12.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. Notice of hearing was issued to the parties for 24.03.2021 through V.C. in D.C. Office, Ludhiana. The appellant comes present to attend the hearing through V.C. He states that only partial information has been provided to him.
- 3. Neither the PIO has come present to attend the hearing nor he has sent any of his representatives to attend the hearing and no intimation in this regard has been received from the PIO. This indifferent attitude of the PIO is viewed adversely.
- 4. The Public Information Officer, O/o Punjab State Power Corporation Ltd., Ludhiana is issued show cause notice to explain his absence as also as to why penalty should not be imposed in the instant case for not supplying complete information to the appellant.

The PIO is also directed to file a written reply to the show cause notice as to why the appellant should not be compensated for the mental harassment suffered by him in getting the information.

- 5. In addition to the written reply, PIO is hereby given an opportunity u/s 20(1) proviso thereto for a personal hearing before the imposition of such a penalty, on the next date of hearing. He may take note that in case he does not file the written reply and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceeding against him ex-parte.
- 6. The PIO is now directed to call the appellant to his office and allow him access to the relevant official records. The appellant, after inspection of records, will identify the information required by him and the same will be provided to the appellant. The PIO is further directed to file an affidavit on a non judicial stamp paper in the instant appeal case duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.293/2021 has been supplied to the appellant. It be further stated that nothing has been concealed therein and the statement made is true and correct. Original copy of affidavit along with a photocopy of the same as also the related official records be brought along and produced before the Bench on the next hearing.
- 7. With the afore said directions, the matter is adjourned. To come up for hearing on 09.06.2021 at 11.30 AM before the Bench in Commission's Bench at Chandigarh. Copies of the order be sent to the concerned parties.
