Present : The Appellant, Sh. Kamal Dev is absent.
None is present from the Department.

ORDER:

This case was last heard by the undersigned on 07.03.2022 .

In today's hearing, both the parties are absent.

After going through the case file it has been observed that on the last date of hearing dated 07.03.2022, both the parties were absent and in the order it was mentioned that:-

".....The appellant, through a letter dated 20.12.2021, which has been received in the Commission vide Diary No. 28627 dated 21.12.2021 , has intimated the Commission that Insecticide Register for the period of year 2003 – 2004 and statement of Wheat Crop Year for the period of year 1999 - 2000is still pending. It is taken on record.

Nevertheless, a copy of this order be sent alongwith letter dated 20.12.2021 (sent by the appellant) through registered post to Public Information Officer office of District Manager, Punjab State Warehousing Corporation, Ferozepur, with the directions to supply the remaining information, after removing the deficiencies, to the appellant through registered post by the next date of hearing with a copy to the Commission....."

Moreover, a letter dated 16.05.2022 from the Appellant, Sh. Kamal Dev has been received in the Commission vide diary number 10561 dated 19.05.2022 in which he has written that:-

"..... It is prayed that above appeal file of 2425 of 2020 may please be closed as the complete information of insecticides is not being supplied despite of repeated requests and direction given by Hon'ble Commission....."

In view of above, it has been observed that the Appellant doesnot wants to pursue this case any further. So, no further intervention is required in this case. The show cause notice which was issued to the PIO concerned vide order dated 22.09.2021 be **dropped.**

This case is disposed of and closed.
