### **ORDER**

- 1. This order may be read with reference to the order dated 10.05.2022 passed by this Bench on the previous hearing.
- 2. The case has been heard today in Commission's office at Chandigarh. Shri R.C. Tandon comes present to attend the hearing in person before the Bench.
- 3. Shri Pawan Kumar, S.D.O. Public Health/PIO, Jalandhar Development Authority, Jalandhar, Shri Rakesh Kumar, Superintendent/APIO and Shri Yogesh Kumar, Senior Assistant O/o E.O. Regulatory, Jalandhar Development Authority, Jalandhar, also come present to attend the hearing in person before the Bench. He states that the information has been supplied to the appellant vide letter dated 08.11.2021. He also produces before the Bench the original affidavit signed by the APIO O/o Estate Officer (Regulatory), J.D.A. Jalandhar, attested by the Notary Public and also the reply to the show cause notice. On the asking of the Bench, he hands over original affidavit to the appellant and a copy of the same to the Bench.

4. The Bench, on perusal of the affidavit, observes that the same is in order as the appellant had desired that the affidavit be signed by the APIO and not PIO. The Bench also observes that the reply to the show cause notice produced before the Bench by the APIO O/o Estate Officer, Regulatory, J.D.A. Jalandhar is in order, which is accepted and the show cause notice is dropped.

5. On the asking of the Bench, Shri Yogesh Kumar, representative of APIO hands over original affidavit to the appellant. The appellant, however, is not inclined to go through the affidavit and states that he he has not been provided the copy of zoning plan and the copy supplied is of the lay out plan. He also states that he has been charged compounding fee contrary to the policy applicable in an unauthorised colony and that he has not made construction beyond the approved plan as has been alleged by Jalandhar Development Authority. He states that this is being done to him as corrupt practices prevail in the Jalandhar Development Authority. He also arrogates himself to be a strong supporter of the Government's fight against corruption.

- 6. Shri Rakesh Kumar, APIO contends the claim made by the appellant and states that the appellant had made construction beyond the sanctioned plan and he has himself admitted the lapse and then removed the same. He o produces before the Bench a document submitted duly signed by the appellant in this regard. The same is taken on record.
- 6. The Bench also gives opportunity to the appellant to inspect the original record brought along by the APIO by sitting in the adjacent court room so as to enable the appellant to see the record himself and go out fully convinced and reassured.
- After hearing the version of the appellant and the APIO, the Bench finds that the affidavit filed by the APIO is in order. The Bench appreciates the concern of the appellant regarding the eradication of corruption prevailing in the society. The Bench also observes that the appellant has put across his views for almost an hour which were heard though not related to the appeal case. Post deliberations, the Bench feels that adequate information stands supplied to the appellant.
- 8. In view of the above, the Bench does not feel that there is any scope for further intervention in the matter. **The appeal case is disposed of and closed.** Copies of the order be sent to the concerned parties.
