vague term that it would be provided to the Appellant before the next date of hearing. Commission takes a serious view of this casual approach.

**Due to evasive attitude of the representative of the Respondent/PIO, O/o SDM, Maur and wasting the valuable time of the Court as well as of the Appellant, a 'collectively' compensation of Rs. 5000/- (Rupees Five Thousand Only) is awarded to the Appellant, Sh. Manjit Singh for the above mentioned five cases. The compensation shall be paid by public authority concerned (O/o SDM, Maur) by way of crossed Cheque/Demand Draft in the name of Manjit Singh. The crossed Cheque/Demand Draft shall be made from the bank account of public authority concerned (O/o SDM, Maur) and not from the individual official.**

Last opportunity is also given to the PIO/Respondent to deposit the penalty amount of Rs. 5000/- in the Govt. Treasury under the head "0070-Other Administrative Services-60-Other Services-800-Other Receipts-86-Fees under the Right to Information Act" before the next date of hearing.

An email dated 23.06.2019 has also been received from the representative of the Respondent/PIO, vide which Advocate, Sh. Tejinder Singh stated that all case related files are with him and further requested for an adjournment from today's hearing as he has gone out of town.

After going through the case file and discussing with both the parties, the Respondent/PIO is directed to supply the requisite information as per the RTI Application through registered post to the Appellant before the next date of hearing and if the information is not available with them then the Respondent/PIO is directed to file a proper reply in the form of an affidavit signed by the PIO. The Respondent/PIO is further directed to appear in person or through any of his representative along with the postal receipt through which the requisite information will be sent to the Appellant, failing which a strict action would be initiated against the PIO, on the next date of hearing.
