2. Sh. Dinkar Sehgal, JA states that requisite information has already been provided to the appellant as mentioned on previous hearing dated 07.05.2019 and also submitted the copy death certificate of the appellant to the Commission, which is taken on record and also requested the Commission to close this case.

3. After hearing the respondent and going through the documents placed on record, it is found that requisite information and/or written reply has already been provided to the appellant and no therefore, no further action is required in this case and the case is decided on merit basis, hence, this instant complaint case is **disposed of and closed.**
