He also points out that sealing of buildings can be done under Municipal Corporation Act, 1976 not of vacant plots and through point no. 04 of the RTI request, he has demanded that under which section and Act, the seals were put on the vacant plot of the appellant and in the reply given by the respondent, no particular clause or section of Municipal Corporation Act, 1976 has been mentioned, through which seals were put on the vacant plot of the appellant.

The respondent-PIO concerned is <u>directed to file a proper reply to the</u> <u>query, raised by the appellant at point no. 04 through his RTI request, mentioning the clause or section of Municipal Corporation Act, 1976, under which procedure, seals were put on the vacant plot of the appellant, before the next date of hearing. <u>A copy of this order be sent to respondent-PIO concerned through registered post.</u></u>

**ORDER** 

In the above mentioned Complaint case, a penalty of Rs. 5000/- was imposed upon the two PIOs of M. C., Ludhiana { i. e. Sh. A. K. Singla, S. E. (B & R) and Sh. H. S. Khosa, XEN(B & R) } in equal proportion and a compensation of Rs. 1500/- was awarded in favour of the complainant, Sh. Balbir Aggarwal Vide orders dated 17.08.2011. Further a Civil Writ Petition No. 23908 of 2011 was filed by the respondents in the Hon'ble Punjab and Haryana High Court to set aside the order and the same has been dismissed vide orders dated 04.09.2017. Accordingly, a letter vide no. 17 dated 17.01.2018 was sent by the Commission to Commissioner, Municipal Corporation, Ludhiana to recover the penalty amount from the concerned PIOs and to pay compensation to the complainant, Sh. Balbir Aggarwal under intimation to the Commission. Further, a reminder vide letter no. 37 dated 15.01.2019 was again sent by the Commission to Commissioner, Municipal Corporation, Ludhiana to recover the penalty amount from the concerned PIOs and to pay compensation to the complainant, Sh. Balbir Aggarwal. As no information or intimation in this regard was received in the Commission, the above mentioned complaint case was re-allocated to the Bench of the undersigned for taking further necessary action regarding recovery of penalty amount and payment of compensation. Accordingly, the case is fixed for today for hearing.

The complainant, Sh. Balbir Aggarwal, is not present in today's hearing.

After examining the documents placed on record, it is found that a notice of hearing issued by the Commission on 19.06.2019 in the name of the complainant, Sh. Balbir Aggarwal is received back as 'undelivered' through Diary No. 12115 dated 24.06.2019. It is taken on record.

After examining the documents placed on record, it is found that the respondent PIO through a reply vide letter no. 551 dated 23.07.2019 signed by Executive Engineer (Establishment), Municipal Corporation, Ludhiana, which has been received in the Commission vide Diary No. 14257 dated 25.07.2019, has requested the Commission for an adjournment in

this case as the instant complaint case is very old and the concerned officials, who were the then (two) PIOs of M. C., Ludhiana, namely: Sh. A. K. Singla, S. E. (B & R) and Sh. H. S. Khosa, XEN(B & R), are retired from their official services about 04 to 05 years ago and to ensure the compliance of the orders of the Commission, efforts have been made to trace-out the relevant official record but till date it has not been traced and a letter has also been sent to the then (two) PIOs of M. C., Ludhiana i. e. Sh. A. K. Singla, S. E. (B & R) and Sh. H. S. Khosa, XEN(B & R) respectively, to submit receipt challan of penalty amount, if deposited by them in Treasury. It is taken on record.

Another opportunity is given to the to the Nodal Public Information Officer office of Commissioner, Municipal Corporation, Ludhiana to confirm the compliance of the order passed by Hon'ble Punjab and Haryana High Court on 04.09.2017 in a Civil Writ Petition No. 23908 of 2011 by submitting a copy of challan/receipt through which penalty amount of Rs. 5000/- (which was imposed vide orders dated 17.08.2011) was deposited in Government Treasury by the then (two) PIOs of M. C., Ludhiana { i. e. Sh. A. K. Singla, S. E. (B & R) and Sh. H. S. Khosa, XEN(B & R) } in equal proportion and also submit a copy of Demand Draft/Cheque through which compensation (which was imposed vide orders dated 17.08.2011) was paid to the complainant, Sh. Balbir Aggarwal.

Accordingly, <u>A copy of this order be sent through registered post in the name of the Commissioner, Municipal Corporation, Ludhiana</u> to ensure the compliance of the abovesaid order under intimation to the Commission.
