



Invoking the proviso of Section 8(2) whereof the larger public interest outweighs the personal harm, if any, the Commission overrules the defence taken by the respondents and directs them to pass on the information under intimation to the Commission."

The case has again come up today for hearing. The status quo remains. Apparently,

the respondents have refused to comply with the order of the Commission. The Commission takes it as a willful attempt of suppression of information by the respondents. The PIO has rendered himself liable for penal consequences having controverted the provisions of Section 7(1) of the RTI Act.

Dr. Vipin Malhotra, PIO – cum – Health Officer, MC office, Ludhiana is issued a show cause notice to explain in a self- attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to maximum of Rs.25,000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing willful delay / denial of the information to the RTI applicant and why the Appellant be not awarded to the Complainant under Section 19 (8) (b) of the Act for the detriment suffered by him.

In addition to the written reply, the PIO is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex parte."

The matter has come up today. Dr. Vipin Malhotra is present in the court and has filed an affidavit as a reply to the show cause notice. He has submitted that the information sought could be accessed from two sources i.e. his service book and service file. He states that they have not been able to trace his service file despite their best efforts. His service book was in movement for the entry of a proficiency stop up and as such the information could not be provided with in the stipulated period. More so, the concerned official had requested the PIO not to part with the information. Nonetheless in compliance with the
