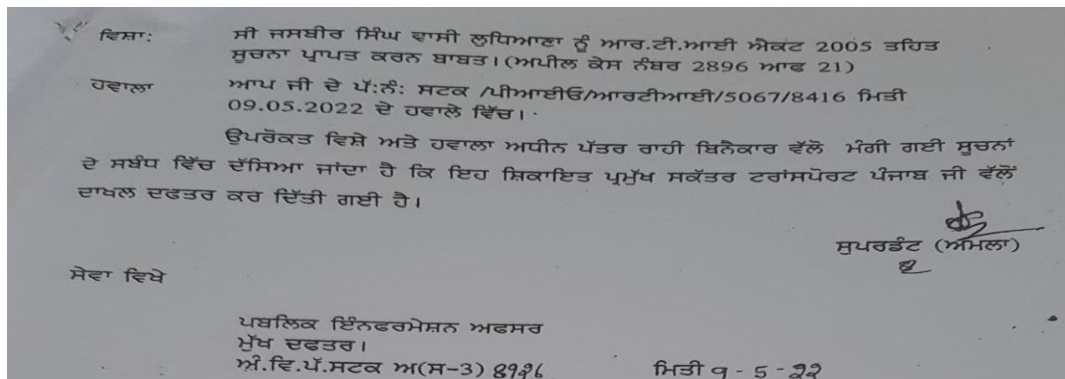

4. The appellant states that he had pointed out deficiencies in the supplied information as per the previous orders of the Commission dated 26.05.2022 but till date has not been removed.
5. After hearing the case in detail, the court directs the respondent to remove the deficiencies or supply an affidavit in original as per RTI application to the appellant within 7 days from today with under intimation to the Commission.
6. In view of above, the court does not see any further course of action required in the present case, therefore, the case stands **disposed of/closed**. Copy of the order be sent to the parties.
