The respondent stated that till today the appellant has not deposited the assessed fee of Rs.53,190/- in the office of the PIO that is why the information could not be provided to the appellant. The respondent further stated that in case the appellant would deposits the assessed fee in the office of the PIO, then the sought for information would must be provided to him.

The Commission has received a mail sent by the PIO on 03.09.2019 and diarized vide no.16867, which is a copy of letter no. 5691 dated 28.08.2019 and it is submitted in the letter that till today the appellant has not deposited the assessed fee in the office of the PIO.
