ORDER:

This case was last heard on 28.10.2020 vide which the Respondent / PIO concerned was directed to supply the information to the Appellant and the Appellant was directed to confirm the same whether the information has been received by him or not.

In today's hearing, Sh. K.S. Bhatia states that whatever the information was available with them, it have been sent to the Appellant as well as to the Commission. He further states that the information has been sent vide memo number 7324 dated 27.10.2020 along with supporting documents, which has been received in the Commission vide diary number 15395 dated 02.11.2020 and the same is taken on record.

On this, the Appellant, Sh. Manish Kaushal states that the status of the case is same as the Department is still not supplying the information to him and sending him the vague replies. He further mentions the Commission to go through his email dated 22.11.2020, which is taken on record.

On having the point wise discussion with both the parties, it is found that information is remaining to these three points which have been discussed during the hearing and the same has to be supplied by the concerned Department.



1. On asking Sh. K.S. Bhatia that when Smt. Madhuri Saxena was appointed from Foreman to Sports Officer, whether her Cadre was changed or it was a fresh appointment, on which Sh. K.S. Bhatia states that it is a fresh appointment. On further discussing with Sh. K.S. Bhatia it is found that he is going to retire from the services in three days, so Sh. K.S. Bhatia is directed before his retirement to submit the same in writing that 'Smt. Madhuri Saxena was appointed from Foreman to Sports Officer, under the fresh appointment,' along with the specific dates. Sh. K.S. Bhatia is also directed to supply the same to the Appellant along with a copy to the Commission within three days vide registered post.
2. On further discussion it is also found that the reply which has been given by the Department which is signed by Dy. Secretary/ Services – II, PSPCL, Patiala vide memo number 7324 dated 27.10.2020 having two names in it while supplying the information i.e. in point number 01 they have written Smt. Madhuri A Singh and in the same letter at point number 04 they have written as Smt. Madhuri Saxena, so it the duty of Dy. Secretary/ Services –II, PSPCL, Patiala to clear the facts that whether in this letter they are giving information to the Appellant relating to one person or two different person, or if the name of the person has been changed, then supply the same in writing or supply an affidavit of 'name change' to the Appellant as well as to the Commission through registered post before the next date of hearing.

ORDER:

This order may be read with reference to the previous order dated 09.09.2020 vide which Appellant, Sh. Manjinder Singh intimated the Commission that incomplete information has been supplied to him. The Appellant was directed to visit the Respondent's office on 24.09.2020 at 11:00 A.M. (along with earlier supplied documents) for collecting the specific information after inspecting the record

In today's hearing, Appellant, Sh. Manjinder Singh states that he has received the requisite information and he has no objection to close this present case.

The PIO, Sh. Baljeet Singh states that requisite information has already been supplied to the Appellant and requested to close this case.

After hearing both the parties and examining the case file, it is observed that requisite information stands supplied and now this case is only pending regarding penalty to be deposited or not.

As matter is pending in CWP 1326 of 2020 before the Hon'ble Punjab and Haryana High Court regarding the penalty imposed on the Respondent/ PIO amounting to Rs. 2,500/- (imposed vide order dated 27.11.2019).
