Heard through facility of Software/application 'CISCO Webex Meetings'.

The RTI request is dated 07.08.2020. First appeal is dated 14.09.2020. Second appeal has been received in the Commission on 02.12.2020.

On the last date of hearing, held on 06.09.2021 ;

- i) Sh. Harjinder Singh, Superintendent, Division – II, Gurdaspur, stated that the requisite information was sent to the appellant vide letter no. 2697-98 dated 26.07.2021.
- ii) Sh. Sukhdeep Singh Dhaliwal, Executive Engineer, Batala, stated that he had charge of both the Division I and II and certified copies of the requisite information of three hundred fifty nine pages was sent to the appellant vide letter dated 06.07.2021. He stated that certified copies of the requisite information of two hundred and eighty six pages was supplied to the appellant vide letter no. 3244 dated 16.07.2021.
- iii) Sh. Arvind Sharma, Senior Assistant, Division – I, Gurdaspur, stated that the requisite information was sent to the appellant vide letter no. 4131 dated 18.06.2021.

- vii) An opportunity was also given to the appellant to confirm whether he received the information, and also to point out deficiencies, if any, in the information supplied to him, in writing, to the concerned respondent PIO/PIOs of other concerned Divisions (From whom he has received the information) well in time so that the same could be removed by the respondent PIO/PIOs concerned.

The appellant, Sh. Surjit Singh Aujla, is absent from today's hearing without any intimation to the Commission. He has also not approached the Commission with any contrary claim .

Sh. Sukhdeep Singh Dhaliwal, Executive Engineer, Batala, who appeared in person in today's hearing, states that the appellant did not visit the office of the respondent to inspect the relevant official record on 15.09.2021 as directed vide orders dated 06.09.2021.
