

The RTI request is dated 23.07.2020. First appeal is dated 09.08.2020. Second appeal has been received in the Commission on 11.01.2021.

On the last date of hearing, held on 08.09.2021;

- i) The appellant stated that no information was supplied to him by the respondent PIO.

- V) An opportunity was given to the appellant to confirm whether he received the information and also to point out deficiencies, if any, in the information supplied to him, in writing, to the respondent PIO so that the same could be removed by the respondent concerned.

The appellant, Sh. Rakesh Kumar Gupta, Advocate, who appeared in in today's hearing, states that no information has been given to him by the respondent PIO till date.

Neither the respondent PIO nor any of his representative is present in today's hearing.

As the RTI request of the appellant is addressed to office of Director, Local Government Punjab, Chandigarh and on the hearing, held on 23.06.2021, Ms. Sunita Rani, Superintendent-cum-PIO(Establishment Branch), was present and intimated that the information sought by the appellant through RTI request relates with office of Nagar Councils, Municipal Corporations and Improvement Trusts of various Districts and sought an adjournment in this case so that the required information could be supplied to the appellant.

Afterwards, on the hearing, held on 08.09.2021, neither she (Ms. Sunita Rani, Superintendent) was present during the hearing nor sent any document showing that the required infortmion had been given to the appellant.

After examining the documents placed on record, it is found that the respondent PIO through reply vide letter no. 42855 dated 21.10.2021 signed Superintendent(Establishment Branch)-cum-PIO, which has been received in the Commission vide Diary No. 24010 dated 25.10.2021, showing that directions Superintendent(Establishment Branch)to the Executive Officer, Nagar Council, Mullanpur Dakhan to supply the required infortmion to the appellant. It is taken on record.

As the RTI request is dated 23.07.2020 and directions were given by Superintendent(Establishment Branch) to the Executive Officer, Nagar Council, Mullanpur Dakhan to supply the required infortmion vide letter dated 21.10.2021, which is after eight months of the proceedings of this case, is not acceptable. Moreover, a show-cause notice was issued vide orders dated 08.09.2021 with the directions to the concerned PIO Superintendent-cum-PIO(Establishment Branch) to appear before the Commission personally but he/she did not visit the Commission to attend the hearing. The requisite information has also not been supplied by the respondent PIO to the information seeker even after a period of more than one year, even after the directions were given vide orders dated 23.06.2021 and 08.09.2021, which reflects that he/she is trying to delay in supplying the required information to the information-seeker. The Commission took a serious view of this casual approach of the respondent PIO.

For making delay in supplying the requisite information to the information-seeker under Section 20 (1) of the RTI Act, a penalty of Rs. 5,000/- (Rupees Five Thousand Only) is imposed upon the concerned Public Information Officer, who is Superintendent-cum-PIO(Establishment Branch) office of Director, Local Government Punjab. - ii) An opportunity was given to the appellant to confirm whether he received complete information or to point out deficiencies, if any, in the information supplied to him, in writing, to the respondent PIO well in time so that the same could be removed by the respondent concerned.

Sh. Ravinder Singh, Section Officer, who appeared on behalf of the respondent PIO in today's, states that complete information has already been supplied to the appellant vide letter no. 2343 dated 26.08.2021. He also intimates the Commission that a reply, alongwith a copy of supplied information of eighty pages has also been sent to the Commission vide letter no. 2342 dated 26.08.2021, which has been received in the Commission vide Diary No. 19151 dated 26.08.2021.
