The respondent further submitted that whenever the report from the Home Department will be received and the challan will be submitted before the concerned Court, then the information will be sent to the appellant.

A show cause notice was issued to the SPIO on the last date of hearing. As per the facts submitted in the status report the delay in providing the information is due to the reasons mentioned in the status report. So, I withdraw the show cause notice and the present
