First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 4.6.2021 and second appeal was filed in the Commission on 8.10.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information:-

3. The appellant is absent without intimation. However the representative of the respondents sent the information through email, which is taken on record, regarding the sought information but none is present on behalf of the respondent due to strike by the officials of the respondent authority.

ORDER

The RTI application is dated 24.6.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 2.8.2021 and second appeal was filed in the Commission on 6.10.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information:-

3. The appellant is absent but he has sent the written submission in this case, which are taken on record. However the representative of the respondents sent the written intimation sent to the appellant vide No. 7694 dated 10.8.2021 to deposit the fee of 200 pages regarding the sought information, which is taken on record. However, none is present on behalf of the respondent due to strike by the officials of the respondent authority.

4. Keeping in view the above the directions are issued to the respondent-Public Information Officer to supply the information free of cost to the appellant within two weeks as the fee has been demanded after the period as per the provisions of the RTI Act, 2005. However, the liberty is granted to the appellant to approach the Commission within four weeks in case he does not receive the information as enumerated above for the consideration of the Commission. Also a copy of the letter dated 10.8.2021 is being **sent** to the appellant along with this order.

This order may be read with reference to the previous order dated 8.11.2021.

2. The appellant has sought the following information:-

3. The appellant states that the copy of allotment letter as has been sought by him has not been supplied by the respondent. However, the representative of the respondent states that the allotment letter is not available in the office as it pertains to year 1975. He further states that it is a fact on record that the appellant is depositing the rent with the Deputy Commissioner's office. Furthermore, the representative of the respondents states that a copy of the said register can be supplied to the appellant regarding receipt of the rent within a week, with which the appellant agreed to.

4. Keeping in view the assurance given by the representative of the respondent the respondent Public Information Officer is directed to supply the copy of rent register as has been assured during the hearing within a week. With these directions the case is disposed of and closed. However, the liberty is granted to the appellant to approach the Commission within four weeks in case he does not receive the same from the respondent authority.
