ORDER

This order may be read with reference to the previous order dated 16 December 2021 vide which the case was adjourned for 24 January 2022 but due to administrative reasons the case could not be heard on the said date and further adjourned for 24 March 2022.

2. This case was earlier heard by the Bench of Shri Avtar Singh Kaler, State Information Commissioner, Punjab. As he has demitted the office, therefore, the case was reallocated to this bench. 4. Also the respondent Public Information Officer is directed to pay the compensation to the appellant, as has already been awarded, amounting to Rs.3000 before the next date of hearing. Also, no reply has been received from the Public Information Officer o/o the Block Development and Panchayat Officer, Fazilka regarding show cause notice issued to him on 30 November 2021 for the imposition of penalty in this case. One opportunity is granted to the Block Development and Panchayats Officer, Fazilka to file his reply before the next date of hearing failing which ex-parte decision will be taken on the next Date of hearing.
