3. The complainant submits that the directions may be issued to the respondent-Public Information Officer to supply the information in this case.

4. It is appropriate to mention that Hon'ble Supreme Court of India in its order in Civil Appeal Nos.10787 – 10788 of 2011 (arising out of SLP © No.32768-32769/2010) has held that while entertaining a complaint under Section 18 of the RTI Act, 2005, the Commissioners have no jurisdiction to pass an order providing for an access to the information. Since the complainant has approached the Commission under the provisions of Section 18 of the RTI Act, 2005, no directions for providing further information can be given by the Commission. A copy of the submissions made by the appellant is also being sent to the First Appellate Authority along with this order.

An alternative and efficacious remedy of first appeal is available to the complainant under Section 19(1) of the RTI Act, 2005 which has not been availed in the instant case. The complainant further submits that he is interested in getting the information, therefore, the matter is remanded to Ms Ruhi Dug, IAS, Addl. Deputy Commissioner-cum-First Appellate Authority, Amritsar to take appropriate decision in accordance with the provisions of the RTI Act within four weeks, after giving opportunity of hearing to all concerned by passing a speaking order.

5. With these directions the case is disposed of and closed. However, the liberty is granted to the complainant to approach the Commission in this case within six weeks if he is not satisfied with the decision of the First Appellate Authority.

3. The representative of the respondents submits that the complete information as available on record along with the specific reply has already been sent to the appellant. She further submits that the opportunity was also granted to the appellant to inspect the concerned file but he did not come forward to inspect the same.

3. The representative of the respondent on behalf of the Municipal Corporation, Ludhiana submits that as per the official record no rule exists vide which the Tax Superintendent Register No. 1 (TS-1) form from Municipal Corporation, Ludhiana has been made mandatory for the registration of sale deeds in District Ludhiana. The respondent Public Information Officer Shri Jeevan Garg Sub Registrar, Ludhiana East further submits that the form TS-1 is being taken from the Municipal Corporation, Ludhiana in the cases where the Jamabandi of the area does not exist i.e. the core area of the city from Block 1 to 25. He further submits that the Sub Registrar has to personally satisfy regarding the ownership of the seller in accordance with the rules/instructions of the Government. Due to non existence of the Jamabandi, as per the prevalent practice, the form TS-1 is being obtained from the Municipal Corporation, District Ludhiana. Furthermore, he submits that getting the TS-1 from the Municipal Corporation is in the interest of the state exchequer as the form TS-1 is issued after clearance of all pending dues, if any. The respondent-Public Information Officer further submits that this practice is being adopted in the Ludhiana district only and no other district has adopted such a procedure. He has also handed over a copy of government instructions under which the Sub Registrar has to satisfy himself, in compliance of amendment of Para 135 of the Punjab Registration Manual 1929 w.r.f. Statutory provisions of Transfer of Property Act and Registration Act, 1908, which is taken on record. He also submits that a reference will be sent to the Financial Commissioner (Revenue) for consideration regarding replication of the same in the State.

4. After hearing both the parties, it has transpired that there are no instructions to get the TS-1 from the Municipal Corporation, District Ludhiana to get the property transferred as has been sought by the appellant. Therefore, no further directions can be

given to the respondent authorities as per the provisions of the RTI Act, 2005. However, a copy of this order is being sent to the Financial Commissioner (Revenue) and Principal Secretary, Local Government to examine whether the practice of taking form TS-1 (as is being done in Ludhiana) for the recovery of pending dues before the registration is required to be adopted in all the Municipal Corporations of the State.

5. Keeping in view the above, the case is disposed of and closed.
