The appellant has sought the following information in his RTI application:

- C. Particulars of Information Required: The information against the below mentioned points are called duly certified and pages duly numbered along with an index. The points of information are detailed below:
- A) Certified copy of all the detail of the interlocking tiles which have been supplied to which-which villages under the Block Khanna in which interlocking tiles have been supplied / purchased by the Gram Panchayat/ Village panchayat, through any process /official of any village under the subjected BDPO, Block Khanna, Khanna from 1-1-2019 till date. (information to be supplied on CD/DVD/Pen drive)
 - B) Certified copy of all the bills against which the interlocking tiles have been purchased from any manufacturer, supplier etc in the village's under the block Khanna since 1-1-2019 till date. (information to be supplied on CD/DVD/Pen drive)
 - C) Certified copy of the detail of amount of grants received and from which source to all the villages under the control of the subjected public authority of the Block Khanna and the amount of the grant utilised till date along with the complete detail of the projects on which the grant was utilised from 1-4-2016 till date. (information to be supplied on CD/DVD/Pen drive)
 - D) Certified copy of the test report procured after drawing of the interlocking tiles against the batches of the interlocking tiles purchased from different source/manufacture by different villages under the subjected public authority during 1-4-2016 till date. (information to be supplied on CD/DVD/Pen drive)
 - E) Certified copy of the circular, section of the act under which the material purchased such as interlocking tiles, sand etc. can be utilised at sites in the villages without getting properly tested before releasing the payments of such material to the supplier or manufacturer.
 - F) Certified copy of the name of the firms allotted for whom the interlocking tiles are authorised to be purchased on the village's under the public authority of BDPO, Block Khanna.

2. The appellant is absent without the intimation to the Commission. However a copy of order dated 24.5.2022 was sent to him through registered post intimating him proceedings and next date of hearing.

3. The representative of the respondents states that the appellant has sought information pertaining to 67 village and each village has different PIO. The sought information is not available in her office and it has to be got collected from 67 PIOs and appellant should need to apply to different PIOs. to get the information. She reiterated that Compensation amount of Rs 4000/- and information containing 455 pages of 33 villages
