Order

A new Division Bench consisting of Sh. Suresh Arora, Chief Information Commissioner, Punjab and Sh. Anumit Singh Sodhi, SIC was constituted and the hearing was fixed for today i.e. 24.8.2022.

2. The appellant is absent today without any intimation to the Commission. He was sent notice of hearing dated 4.8.2022 through registered post which was delivered to him on 8.8.2022.
