- 1. The complainant, Raghubir Singh, filed this RTI application dated 29.6.2020 and sought information by way of the footage from CCTV Cameras installed in Thana Sadar, Moga etc., from the PIO o/o SSP, Moga. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on 14.8.2020. The case was last heard on 26.2.2021.
- 2. Both parties are present via Video Conference from Moga. As directed at the last hearing on 26.2.2021, the respondent PIO-cum-SSP Moga has submitted an affidavit regarding this RTI application. It is this Commission's view that the respondent PIO-cum-SSP has addressed this RTI application to maximum extent it can be at this stage. The complainant has objected to portions of the affidavit with regard to Point No. 3 of his RTI application.
- 3. However, in view of the fact, most CCTV Camera footage is setup to get automatically deleted after a specified number of days/weeks, unless ordered to be preserved by a Court or other competent authority. The SSP has clarified that none of the CCTV Footage, requested in this RTI application, is currently available.
- 4. Under the circumstances, there is no further cause for action and this Complaint Case is herewith **CLOSED**.

ORDER:

- 1. The RTI application is dated **26.2.2021** vide which the appellant has sought information regarding cases related with Sandeep Hans IAS, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **15.3.2021** and Second Appeal was filed in the Commission on **26.4.2021** under Section 19 of the Right to Information Act 2005. Notice was issued to the parties for first hearing in the Commission on **7.4.2021**.
- 2. Both parties are present via Video Conference Facility from Moga. The respondent PIO stated that the information regarding Point No. 1 and 2 was sent to the appellant vide Letter No. 364 Dated 15.6.2021. The appellant stated at this hearing that information pertaining to Point No. 3 is nonspecific and can be provided if the appellant specifies particular mutations/intkals whereon the District Magistrate's decision can be supplied by way of copies. The appellant is not able to list specific mutations.
- 3. Under the circumstances, this Commission is of the view that this RTI application has addressed adequately. There is no further cause for action and this Appeal Case is herewith **CLOSED**.
