The Appellate Authority as well as the Law Officer, Head Office whom were directed to ensure the supply of information to the Appellant come in person today and state the information has been given to the Appellant. However, the Appellant states that as has been informed by him vide letter dated 13.03.2019, the information supplied is incomplete as he has still not received information regarding 3 court cases and the Law Officer is shown the list of these 3 court cases by the Appellant. The Law Officer states that only one case relates to Law Branch and the other two relate to Establishment Branch. However, on the asking of the Court, he assures to supply the information to the Appellant in regard to these cases also today itself.

As such, the case is adjourned to next date of hearing which is fixed for **21.05.2019 at 11.00 AM**.

The Appellant had also been advised to get photocopies of documents earlier attached with the compensation case as far as possible so that on the basis of combined documents collected, a file could re-constructed by the office of Assistant Labour Commissioner. During discussions, the PIO had also informed that he was to visit Ropar within a few days, Sh. Jaswinder Singh could meet him at Ropar by establishing contact with him. PIO/Respondent was also directed to take expeditious action to supply the requisite information to the Appellant by taking the steps as suggested by the PIO himself, as above.

Today, Sh.Jaswinder Singh accompanied by Sh.S.K. Vashisht, Advocate come present on behalf of the Appellant. On behalf of the PIO/Respondent, Sh.Barinder Singh, Sr. Asstt. comes present. On the asking of Court, Shri Barinder Singh states that as ordered on the last date, the documents to reconstruct the file are yet to be received from the appellant. The Advocate accompanying the representative of Appellant assures that efforts will be made to make available the documents as far as possible to the PIO/Respondent to help in reconstruction of the new file.

Shri Barinder Singh assures that on receipt of necessary documents from the appellant, the file will be reconstructed and proceedings in the case will be initiated so as to help the Appellant to get necessary compensation benefits as soon as possible.

The matter is adjourned for further hearing on **21.05.2019 at 11 A.M.**
