6. In view of the foregoing, the respondent-PIO is directed to supply application form and copy of form for change of category from general category to 'ward of police personnel' as sought by the complainant under the Right to Information Act, 2005.

The RTI application is dated 27.07.2018 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 08.09.2018 and Second Appeal was filed in the Commission on 28.12.2018 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act).

2. Notice of hearing was issued to the parties for today by the Commission.
3. The appellant states that no information has been received by him till date.

The representative of the respondents states that same information has been sought by

the appellant in AC-3489/2018, which has been disposed of by Hon'ble SIC-A.S. Chanduraian on 25.02.2019. He further states that complete information has been sent to the appellant through registered post. On the direction of the Commission, the respondent hands over one copy more of the information to the appellant during the hearing. After perusing the same, the appellant states that action against the culprit has not been taken by the police till now in DDR No.6 of dated 03.04.2018 lodged in Police Station, Sahnewal. The representative of the respondents states that they have no jurisdiction to take action against the culprit for bounce of cheque.

4. After going through the record available on the case file and hearing both the parties at length, it is revealed that the information seeker is seeking information regarding action taken against the culprit, who has issued a cheque of Rs.10,000/- to him which was bounced on its presentation to the bank. Police has no jurisdiction to take action against the culprit. The appellant is advised to file case in the competent court of law for initiating action against the culprit. Under the RTI regime, complete information as sought by the information-seeker has been supplied. With these observations, the case is **disposed of** and **closed**. Copies of the order be sent to the parties.
