Thereafter, the complainant states that he has not received the same but showed his willingness to deposit the requisite fee before the next date of hearing.

3. Accordingly, the respondent-Public Information Officer is directed to supply the information before the next date of hearing in case the complainant adhere to comply with the submissions of the respondent-Public Information Officer mentioned in para 2 above.
