Order:

The appellant through RTI application dated 01.10.2018 has sought information regarding works undertaken/carried out during 02.10.2017 to 01.10.2018 and other information concerning the office of SDO-Construction Sub Division No.3, PWD (B&R) Bhatinda. The Commission has taken a serious note on the view taken by the PIO as well as FAA who rather than sending the information preferred to asked the appellant to come and collect the information, and violated the spirits of section 7(1) of the RTI Act. Even though the information has been supplied, I hereby show cause the PIO why penalty be not imposed on him under Section 20 of the RTI Act 2005 for asking the appellant to come and collect the information rather than sending the information within the statutorily prescribed period of time, he should file an affidavit in this regard, if there are other persons responsible for the delay in providing the information, the PIO is directed to inform such persons of the show cause and direct them to appear before the Commission along with the written replies.

The PIO is also directed to appear personally alongwith written reply on an affidavit on the next date of hearing.
