Appeal Case No. 2349 of 2020

ORDER:

The appellate through RTI application dated 29.05.2020 has sought information regarding recruitment of 9998 posts of JBT ETT teachers advertised in Sept.2007 – number of applications under SC(M&B) category – copies of caste certificates of SC category – experience certificates of the applicants – the name of verification officers of certificates and other information as enumerated in the RTI application concerning the office of DEO(EE) Hoshiarpur. The appellant was not provided with the information after the appellant filed the first appeal before the First Appellate Authority on 10.07.2020 which took no decision on the appeal.

The case first came up for hearing on **25.02.2021** through video conferencing at DAC Nawanshahar. The respondent present pleaded that the information has already been sent to the appellant vide letter dated 09.01.2021 and again on 25.01.2021. The respondent further informed that the information after the communication of 09.01.2021, the appellant had pointed out some discrepancies, which after being sorted, were sent on 08.02.2021

The appellant was absent and vide an email again pointed out some discrepancies in points No.3,4,6, 8 & 9. However, the letter was not legible. The appellant was directed to send a legible typed copy of deficiencies to the Commission with a copy to the PIO.

It also came to the notice that the appellant had also filed another appeal case No.2259/2020 for seeking exactly the same information from the office of DEO(EE) Mohali which is fixed for hearing on 26.05.2021. The appellant was directed to clarify whether he has sought the same information in this case.

Hearing dated 25.05.2021:

The case has come up for hearing today through video conferencing at DAC Ludhiana/Hoshiarpur. The appellant is absent on 2nd consecutive hearing to pursue his case. However, the appellant vide letter received in the Commission has sent a copy of deficiencies which has been taken on the file of the Commission.

Appeal Case No. 2349 of 2020

The respondent informed that the discrepancies pointed out by the appellant have been sorted out and a reply has been sent to the appellant vide letter dated 27.04.2021 with a copy to the Commission.

Having gone through the RTI application and the information provided by the PIO, I find that the RTI application has now been suitably replied to and the information has been provided to the best possible extent.

No further course of action is required. The case is **disposed of and closed**.
