#### **ORDER**

## (Heard on mobile phone)

4. Shri Avtar Singh, appellant is contacted on mobile phone. In spite of repeated attempts made to contact him, he does not respond to the phone calls. The Bench observes that the appellant was absent during previous hearing also and he was contacted on mobile phone even during the previous hearing without any response. The appellant has not bothered to enquire about the date of hearing or status of the case. The respondent also submits that the appellant has been non-responsive to their mobile phone calls made in connection with his RTI application.

- 5. The conduct of the appellant Shri Avtar Singh, as stated above, shows that he has received the information and he has no further interest in pursuing the appeal case. The Bench feels that adequate information stands supplied to the appellant.
- 6. In view of the position as emerges above, the Bench is not inclined to continue with further proceedings in the instant appeal as the same will amount to wastage of time of the public authority as well as the Commission.
