ORDER

The judgment in this case was reserved on 17.03.2020.

2. The brief of the case is that the Appellant filed his RTI applications dated 26.07.2019. Later on, he filed first appeal under Section 19(1) of the RTI Act 2005 on 04.09.2019 before the First Appellate Authority (FAA). His second appeal with the Commission is dated 23.05.2012 and the case was fixed for hearing on 02.03.2020.

3. During the hearing held on 02.03.2020 , the appellant stated that he demanded information regarding "*construction work has been started of SCO No. 6-11 at Sunny Enclave Premium, Near DMW Colony, Patiala belongs to M/s Baaz Construction Private Limited, Chandigarh. Please allow me to inspect record relating to above stated SCO regarding application for sanction of map plan and provide certified copies of information identified during the inspection.*"

He further stated that no information has been given to him so far.

4. Respondent stated that the information demanded by the appellant is third party information. He has also shown consent of M/s Baaz Construction Private Ltd mentioning therein that their information should not be disclosed. He has also filed his reply which is as under:-

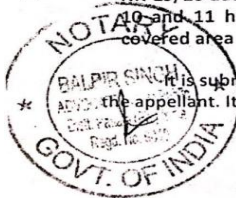

However It is clarified that Building Plan No- NR- 18/1273 dated 28/12/2018, Building plan no NR-19/16 dated 09/04/2019 and Building Plan no- NR-19/17 dated 09/04/2019 for Plot No- 6, 10 and 11 has been sanctioned for Basement, Ground, First and Second floor for total covered area 2175.54 sqft. For plot area measuring 89.77 sqyds for each plot.



It is submitted that the information as available in the official records has been shown to the appellant. It is requested that the case may be closed.
