2. The notice of hearing was issued to the parties for 25.07.2022. Accordingly, the case has been heard today. Lt Col Navraj Dev Singh Bains (Retd), appellant comes present to attend the hearing in person before the Bench.

3. Maj Gen Rambir Singh Mann, VSM, PIO, Director General, C-PYTE, Punjab, Chandigarh/PIO,C-PYTE, Shri Ram Ishwar Singh, Superintendent and Smt. Chhaya Goyal, Senior Assistant O/o Principal Secretary, Department of Employment Generation & Training, Punjab come present to attend the hearing in person before the Bench. The PIO states that the appellant has sought copies of case/noting sheet regarding recovery of pay made from him, the calculation of recovery sheets and case taken up with Chairman, C-PYTE regarding non requirement of his services. He further states that copies of letters dated 30.04.2021 and 20.12.2021 of the Govt. of Punjab regarding recovery from salary of appellant, calculation sheet for excess recovery from salary were supplied to him. He states that



approval of Chairman as per Societies Bye-laws. The case file taken up is classified as confidential and is not with C-PYTE. He also cites a judgment of Central Information Commission in matter of Dr.K.C. Vijayakumaran Nair vs. Department of Post, wherein the appellant had sought notings with respect of his being relieved from a official post, wherein the Hon'ble CIC had held that the disclosure is not in the public interest as the appellant has asked for information for promotion of personal interest and that CPIO is justified in denying information sought under section 8(1)(j) of RTI Act. The PIO also states that the appellant has also filed a case in the Hon'ble Punjab & Haryana High Court in this regard which remains sub-judiced. Smt. Chhaya Goyal, Senior Assistant O/o Principal Secretary, Department of Employment General & Training, Punjab states that the letters regarding recovery from appellant has been supplied to the appellant whereas the calculation of recovery and effecting recovery from appellant relates to office of Director General, C-YTE, Punjab.

4. The appellant Lt Col Navraj Dev Singh Bains (Retd.) states that he does not agree with the contention of PIO Maj Gen Rambir Singh Mann, Director General, C-PYTE that the information asked for is personal information as he has sought information which relates to him only and not of any third party. He further states that the has been given misleading reply and the information has been provided unattested by PIO. He further states that information on point No.3 has not been provided to him.

5. The Bench, post deliberations and on perusal of the RTI application, reply of the PIO and the documents on file, observes that the appellant has been provided documents related to recovery of excess salary drawn, detailed calculation thereof as also letter regarding termination of services issued by Government of Punjab. However, the file notings related to the above have been rightly withheld in the interest of conditional access in larger public interest. The Bench is in agreement with the order of Public Information Officer and the First Appellate Authority on the subject. The Bench, however, directs that all documents provided be duly attested by the PIO.

6. In view of the position as emerges from the aforesaid discussion, the Bench does not feel need for further intervention in the matter. As such, the instant appeal case is disposed off and closed. Copies of the order be sent to the concerned parties.

# ORDER

The RTI application is dated 03.12.2021 vide which the appellant has sought information 1. as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 19.01.2022 and the second appeal was filed in the Commission on 06.04.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

The notice of hearing was issued to the parties for 25.07.2022 in Commission's office at 2. Chandigarh. Accordingly, the case was scheduled to be heard today. Shri Sat Parkash Goyal, appellant comes present to attend the hearing in person before the Bench.

3. Smt. Sheenu Jindal, Clerk O/o Patiala Development Authority, Patiala comes present in person before the Bench and states that point-wise information has been provided to the appellant vide letter dated 24.02.2022 by registered post. No other details are held in official records.

4. The appellant refutes the reply given by the PIO to the RTI application. He states that firstly, the information has been delayed by six months and states it has been informed that the manholes have been covered, whereas, as per latest picture taken by him, the manholes are still seen

uncovered and no action has been taken on their complaint. He further states that no action has been taken to stop various eatery owners from letting the food cooking waste spread on the street which causes problem for the residents. He expresses dis-satisfaction over the information supplied by the PIO.

5. Post deliberations, the Bench directs the PIO to file an affidavit on non-judicial stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.1693 of 2022 has been supplied to the appellant. It be further stated that nothing has been concealed therein and the information supplied is true and correct. The original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

6. With the aforesaid directions, the instant appeal case is disposed off and closed. **The instant appeal case is disposed off and closed.** Copy of the order be sent to the parties.
