**ORDER:** 

The case has been heard through video conferencing.

The following order was made by the bench on 14.08.2019:

# 11.06.2019:

"The complainant is seeking information about the income/revenue having been accrued to the Gram Panchayat, Village Tangrali, Teshil Talwandi Sabo, District Bathinda and the expenditure incurred on various development works during the period 2013 to 2018.

Sh. Jagtar Singh, Panchayat Secretary is present on behalf of the respondents. He submits that the record in question has not been handed over to him by the previous incumbent Shri Harbhajan Singh. The BDPO is directed to ensure that the record is

procured from the said Sh.Harbhajan Singh and an inspection of record by the complainant is

arranged and certified copies of the documents so identified on inspection, not beyond 150

pages are handed over to the complainant free of charge.

14.08.2019

The case has again come up today. Sh. Jagtar Singh, Panchayat Secretary,

submits that the record from previous incumbent has just been handed over to him. He

assures the Commission that he will pass it on to complainant within a couple of days. While

accepting his request, the Commission directs the parties to abide by the conditions laid

above."

The case has come up today. Sh. Jagtar Singh, Pannchayat Secy, submits

that despite his best efforts, the complainant has refused to receive the information. He had

brought it along in the video conference. Even in the course of hearing the complainant is not

inclined to accept it. The respondents are directed to send it by post to him under intimation to

the Commission. No further action is called for. The complaint is filed.
