This order may be read with reference to the previous order dated 16.07.2018 vide which the respondent-PIO was given time with the direction to supply the information before the next date of hearing under intimation to the Commission. The case was adjourned to 19.09.2018 and was postponed to 25.10.2018 due to administrative reasons.

2. The representative of the respondents states that complete information was supplied on 29.07.2018 and again on 23.10.2018 to the appellant, a copy of which has been placed on the record of the case file. He further states that nothing has been
