

3. The complainant is apprised with the order of the Hon'ble Supreme Court of India rendered on 12.12.2011 in Civil Appeal Nos.10787 – 10788 of 2011 (arising out of SLP © No.32768-32769/2010) has held that while entertaining a complaint under Section 18 of the RTI Act, 2005, the Commissioners have no jurisdiction to pass an order providing for an access to the information. Since the complainant has approached the Commission under the provisions of Section 18 of the RTI Act, 2005, no directions for providing further information can be given by the Commission.

An alternative and efficacious remedy of first appeal is available to the complainant under Section 19(1) of the RTI Act, 2005 which has not been availed in the instant case.

4. After hearing the decision mentioned above, the complainant requested for the information. Therefore, the present complaint case of the complainant is treated as first appeal and the matter is remanded back to Sh. Jagdeep Sehgal, PCS, First Appellate Authority-cum-Sub Divisional Magistrate (West) Ludhiana, to take appropriate decision after hearing both the parties and examining the record and pass the speaking order within time

#### 4. The reply filed by the respondent-Public Information Officer is reproduced below:-

Shri Ajay Nand filled First Appeal with the First Appellant Authority of the Commission which was received vide diary no.10748 dated 28-8-2020 for non supply of information with regard to his RTI application dated 28-2-2020 filed with the PIO, office of the H.E. Governor of Punjab. As per documents submitted by him the Governor's Secretariat, Punjab Raj Bhawan, Chandigarh transferred his RTI application u/s 6(3) of the RTI Act, 2005 to the Governance Reforms Department (GR-1 Branch), Mini Secretariat., Chandigarh vide letter dated 6-3-2020. The applicant in his first appeal stated that the Department of Governance Reforms further transferred his RTI Application under section 6(3) of the RTI Act, 2005 to the Punjab State Information Commission. He further stated that the Department of Governance Reforms, (GR-1 Branch), Chandigarh has informed that information with regard to the leaves availed by Shri Nidharak Singh Brar, SIC and detail of complaints filed against him may be obtained from the Punjab State Information Commission.

In this connection, it is submitted that RTI application dated 2-2-2020 filed by the applicant with the HE Governor of Punjab has never been transferred u/s 6(3) of the RTI Act, 2005 by the Department of Governance Reforms (GR-1) Branch, Chandigarh to the Punjab State Information Commission. Since no RTI application has been received in the commission, the requisite information could not be supplied to the applicant. Further, the Commission has also not received a copy of letter dated 21-7-2020 issued by the Governance Reforms Department (GR-1 Branch) vide which the applicant was asked to obtain the requisite information from the Commission.

 No order has been passed on the First Appeal No.AAC-13/2020 filed by the applicant.

4.. In view of the above and also since neither RTI application nor any letter from the Department of Governance Reforms (GR-1 Branch) was received by the Commission, the second appeal filed by the applicant may please be filed

5. The reply filed by the respondent-Public Information Officer was sent to the appellant along with the order dated 4.8.2021 to file the rejoinder, if any and the case was adjourned for 6.9.2021.

6. During the hearing on 6.9.2021 the appellant requested for the adjournment of the case and in the interest of natural justice the case was adjourned for 20.9.2021.
