After hearing the contents of the said letter, the appellant requested that the Tehsildar, Ludhiana East, Ludhiana, may be impleaded as necessary party in this case as a copy of the relevant Vasika No.3363 dated 26.5.1987 was also sent to the Patwari concerned for making entry in the revenue record. With regard to the compensation amount the appellant states that he has received the compensation amounting to rs.5000/- (Rupees Five thousands only) from the respondent-Public Information Officer o/o the Deputy Commissioner, District Ludhiana.

4. Accordingly, the request of the appellant is accepted and the Tehsildar, Ludhiana East, **District Ludhiana is impleaded as necessary** party in this case to file the reply/supply the information in this case before the next date of hearing.
